Butane, isobutane, propane, alcohol, parfum, linalool, hexamethylindanopyran, methylundecanal, citrus aurantium peel oil, geraniol, limonene, amyl cinnamal, ethyl 2-acetyl-4-methyltridec-2-enoate, 3-(4-isobutyl-2-methylphenyl)propanal.
